Occasionally an A. A. gets sick—legitimately —even as the average run of people. When you're laid up for weeks, there isn't much chance of a slip, so how, you wonder, does A. A. come into the picture?

The same way it comes into the picture wherever you are, whatever you're doing, once you get into the thing wholeheartedly. It certainly changed the picture of me as a sick man.

Some years ago, before A. A., I had a bad spell of rheumatic fever—brought on by overdoses of alcohol—and was home in bed for more than a month. I had one caller, just one, in that whole month, and he arrived drunk.

Early this year, after a long stretch of A. A. living, I had to go to the hospital for over two months, and later had to pass a spring and summer of enforced idleness—convalescence the doctors called it. I wish now that I'd kept some count of the people who came to the hospital to see me this time; A. A. s from all over the area, busy men and women who took time out from their jobs and other work to make the fairly long trip to my bedside.

The nurses kidded me, but couldn't contain their wonder at what caused my extreme popularity. I broke all records for visitors and other patients watched with growing amazement as they kept coming.

That was not the important angle, of course. What was so important during this period was that I now had real friends, people who actually cared, friends by the score.

Sitting still is the hardest work in the world for me. By nature, I'm pretty active. I loved the meetings, 12th Step work and all kinds of A. A. get-togethers. Now I've had to sit still for months. Without the understanding I have gained through A. A., without the changed outlook on life which it has brought, I don't know that I could have stood the inactivity.

Not only did my A. A. friends keep me bucked up. All the angles which worked so well to keep me sober before have worked during these months to help me get well faster—and with much less mental anguish.

The 24-hour plan, not worrying about tomorrow—"easy does it" and "first things first" have remained my standbys and helped the days pass faster.

Though I was forced out of active participation, I was certainly not out of things for a day. A. A. included me in on all of the good things of life.

I have been mighty grateful to A. A. for sobriety. Now I am grateful to it for infinitely more.

1. Ask God to direct my thinking, may it be divorced from self-pity, dishonest & self-seeking motives.

2. If I face indecision, ask God to direct my thinking.

3. Ask God for an inspired thought or decision. The right answer will come.

4. Read my daily readings

5. Pray

6. Meditate

7. Go out and help others!

So that's it! I know it seems like a lot but this is what I have to do to maintain a fit spiritual condition!!

Tulare County has started application clearance process. Please contact Joyce R. for details and interest. H&I Panels are continuing as permitted around Covid closures in Corcoran and Avenal Prisons.

At the October 9, 2022 NorCal General Committee Meeting, our restructure proposal and policy revisions were adopted. At the January, 2023 meeting, Area Chairs will now join the voting body of our committee, we will have quarterly meetings which will allow greater communication in our committee. Our policy revisions included a revision on the Statement of Purpose to bring us more in alignment of the work of the General Service Treatment and Corrections Committee. Going forward, we will continue to bring meetings to treatment facilities, jails and prisons and will now look to any facility with serves alcoholics, providing a broader scope of carrying the AA message.

As the restructure brings greater communication, it is even more important for our local AA groups elect an H&I Representative and to attend the business meetings. This will ensure we are carrying the collective conscience of Tulare County to the NorCal Committee.

## Central Service Meeting

Date: October 11th, 2022 Meeting called to order: Cheryl H. Time: 7:03 PM Board members present: Cheryl H., William (Bill) E., Patrick A., Sara S., David G. Absent: none Serenity Prayer: said by all. 12 Traditions: Brett R. Minutes of last meeting: Reviewed by members individually; minor correction noted; also for the Newsletter October Tradition article, Cheryl had volunteered, where Bill had been recorded. Sheryl moved to approve, Bill seconded.

Report of last Board meeting: presented by Cheryl H. Meeting called to order September 13 at 8:33 PM. President's report: nothing significant at this time. Vice-President's report: nothing significant at this time. Secretary's report: David attended the National AA Technology Workshop and they had recommendations for Intergroup websites. David wants to ask to get some Forms software.

Member at Large report (Bridging The Gap) (BTG): Sara attended the Zoom meeting for BTG with Brad and a few other members; they met and went over the handbook for BTG. Sara is going to look into getting some literature for BTG here at the office. Public Information and

Cooperation with the Professional Community (PI/CPC): Patrick appreciated that a member pointed out that PI is also getting pamphlets out to the medical facilities. He took out a couple of boxes tonight to do that. Office Manager report: Carol Ann says operations are going well; no additional report. Elections are in December; Patrick and Bill's first term ends December 31st 2022. Sara hasn't had a full term yet; she took over for Monica. We lowered the price of the big book to \$9.83 plus tax; our other literature has not been lowered. We had new business about an Employee Retention Credit (ERC) - it's a Covid-19 thing that the I. R. S. is giving refunds to non-profit businesses that had a downturn during Covid. During the first quarter of 2020, this office lost about \$6,000. The ERC is 50% of wages up to \$10,000, which in our case would be about \$5,000. (The board is going to decide and talk about that tonight because there have been some issues that have been brought up). The meeting adjourned at 9:15 PM.

Treasurer and Office report: Presented by Carol Ann Gable, Office Manager & Treasurer.

Treasurer / Office Report and Financial Report October 11th 2022 Central Office had an income of \$3,516.39 and expenses of \$5,991.23 for a loss of \$2,474.84. Our Grateful Givers Club brought in \$168 and our Birthday Club brought in \$54.00 in much appreciated contributions. We had \$799.15 in gross sales in 12 transactions for credit and debit cards last month. We had 1 transaction in PayPal for \$20.

We had no VENMO transactions this accounting period, only the Venmo phone expenses. We had 2 VENMO transaction that will be in the next months reports. Traffic and calls have been average.

We want to thank all the groups and individuals who contributed to show their support for Central Office. Office operations are going well and we are still fulfilling our primary purpose of carrying the AA message of recovery. The Big Book is still on sale for \$9.83 here at the Central Office.

I wanted to bring to your attention that we're looking for volunteers for the 12 Step Call List.

We did our quarterly taxes this last week, which put us \$1,600 below our reserve.

Cash report: Our checking account has \$17,347.54, and we have about \$150 in the cash drawer.

Are there any questions for Carol Ann?

(Steve) The loss that we have here; does this happen often? (Carol Ann) It fluctuates. I just ordered literature and specialty chips; that's listed on the report.

Let's see – Literature cost was \$2,000 and the Specialty items were \$700.

(Bill) Those are unique to this month and not like a monthly accrue. So we would be virtually even otherwise; pretty close to being even.

(Carol Ann) It just depends on what the demand is.

(Cheryl) We're going into the holiday season. Central Office traditionally tries to make sure that we have our literature and our specialty items caught up because a lot of people come in and shop for the holidays.

(Carol Ann) I wanted to ask you guys – we're out of the large print Big Books. So if I ordered a case of those, we have to pay for the shipping because it's not a big enough order, to order the large print Big Books. They went like hotcakes. I had no idea they went that fast.

(David) They're going to do a 12 Step Workshop where they specifically tell the members get a large print Big Book because you are going to be writing in the margins. That's going to be October 24, at Bridge Street Drunks.

(Cheryl) Just go ahead and order a case or two. How many are in a case? (10) Go ahead and order two cases. Public Information report: Patrick A. provided the report. Public Information & Cooperation with the Professional Community (P.I./C.P.C.). We inform professionals and future professionals about A.A. - What we are, where we are, what we can do, and what we cannot do. We attempt to establish better communication between A.A. and professionals, to establish simple, effective ways of cooperating without affiliating. A member made the observation that in times past, one would see A.A. pamphlets in local hospitals and urgent care facilities. So I told him I'd get with the office manager; we got it ordered, and I'm happy to announce the supplies came in. So I do have them. That particular individual did offer to volunteer and help go to some of these urgent cares and other businesses to see if they don't mind us putting this little card holder. I will be looking for other volunteers; if somebody in the Porterville or Exeter area could help us get the area covered, that would be great.

Website report: Provided by David G.

For September of 2022 we had 1,442 unique visitors. Page views were 2,890, which is almost exactly double the number of visitors; which means that a visitor hit two pages and then bounced out. The most popular page, as usual, was the Today's Meetings page, with 20% of the views. The front page was second most popular; the third most popular page was the Online Meetings page. The fourth most popular was the Visalia Weekday Noon Valley Group Online AA Meeting at 8% of views. Downloads: the traditional print meeting schedule was downloaded 20 times. The new meeting schedule, English single column, was downloaded 10 times. The same file, three columns, was downloaded 6 times. And the Springville Breakfast Flyer was downloaded 4 times. Devices: 52% of our visitors, are IOS (iPhone), 26% are on Android – so 78% of our visitors to the website are on cell phones. And then time of day: I just threw this one out there. 10% of our visits are between 6 PM and 7 PM, and then there's another 9% between 5 and 6 PM. 9% of our meetings are 11 AM to noon, and another 8% from noon to 1 PM. So that's when people are visiting. That's the statistics – any questions? (No questions)

We had the GSR meeting Wednesday the 5th. No new business; old business of disbursing funds in excess of our prudent reserves was tabled to further discussion and action in December.

October 15, 16, and 17 there's going to be a Mini PRAASA (Pacific Regional A. A. Services assembly) in Yuba City. They will discuss a change to the bylaws to allow money from the prudent reserve to be spent on unplanned items. Currently, the rules allow for 5% to be spent, without going through the annual budget process. The new rule will let 20% of prudent reserve excess to be spent. (Bill) When they're talking about 5% of the prudent reserve, is that fairly old? Established before more expensive technology became available? That's why we're going to roll up to 20%?

(David) Sorry if I explained that poorly. The previous rule for unplanned expenses was 5% of total budget. The new rule will be that -or- 20% of overage, over our prudent reserve.

Bridging the Gap (BtG) Chairperson provided by Sara S. I really don't have anything. I did attend an H&I event and talked to somebody about Bridging The Gap; she had some ideas – I asked her to pass them on to me.


