# The Drunkard's Best Friend

When a farmer in Aroostook County, Maine announces that he is going to bake a cake, he is speaking figuratively. What he means is that he is bored with the loneliness of Aroostook's vast reaches, with the county's most famous product, potatoes, and with life in general; and that, to relieve his boredom, he is going on a vanilla-extract bender. In order to buy liquor he might have to drive as much as a hundred miles over drifted or rutted roads, to reach a town uninhibited by local option. He tipples on vanilla, which is rich in alcohol, because it is easily and legally obtainable, in quantity, at the nearest grocery store. Grocers in local-option towns ordinarily do a thriving vanilla business with alcoholically inclined agrarians, but of late the strange society known as Alcoholics Anonymous has taken root in Aroostook and a disturbing effect on the vanilla turnover has been observed.

"You wouldn't believe it, Ned," one storekeeper lamented to a drummer on a gray day last November, " but my vanilla sales is almost down to normal."

The impact of Alcoholics Anonymous upon a community is not always that striking, but it is doing quite well at its self-appointed task, which, as almost everyone knows by now, is that of helping confirmed drunks to quit drinking. The help is provided solely by alcoholics who, through adhering to a specified program of living, have managed to arrest their own disastrous drinking habits. (A. A. members never call themselves ax-alcoholics, regardless of the length of their sobriety, the theory being that they are ineradicably alcoholics by temperament, and are therefore always vulnerable to a relapse.)

# *Step 4* "Made a searching and fearless moral inventory of ourselves"

When I was first presented with this task of making a searching and fearless moral inventory of myself, I resisted. I thought to myself that my morals were just fine! And I didn't need to write them down! Obviously, I was ignorant of the process of doing a 4th Step and the inventory process. I was suspicious of this step because I feared all it was meant to do was to beat me up for the areas where I was lacking. Not so. No... the 4th Step was there to help me identify those character defects that were blocking me from the sunlight of the spirit and allowing me to grow. And some growing up is just what I needed if I was going to be sober and have a fulfilling life.

In early sobriety I was living up in Clovis. I was going to my committed meetings on a regular basis with my sponsor. At around 6 months sobriety (after relapsing for a year and 9 months, not doing the steps) we were in his car coming home from the Thursday meeting, the Sierra Skypark. It was a meeting that I'd fallen in love with, and I considered it to be my home group. On this night I had shared (with some profanity) how my coworkers at this minimum wage job I had were just some real 'pieces of work'. My shares back then would often focus on other people's character defects, not my own. So, Chet tells me as were driving home that night "You know...I see no growth! You know what you need to do. You should get on with your steps! This was a real gut punch! HOW COULD HE SAY SOMETHING LIKE THAT? Well, there was no growth in my character. I just wasn't drinking.

So I took some action and started working on my 4th Step. First, I made a list of people, institutions and principles with which I was angry. The Big Book tells us to go back through our lives. Nothing counted but thoroughness and honesty. When I first attempted this inventory, I could clearly see the other person's fault and how that affected my self-esteem, my pocketbook or other aspects of my life. But I couldn't see how I contributed to the situation. Then it was pointed out that the Big Book states "Referring to our list again. Putting out of our minds the wrongs of others, we resolutely looked for our own mistakes. Where had we been selfish, dishonest, self-seeking and frightened? Though a situation had not been entirely our fault, we tried to disregard the other involved entirely. Where were we to blame?

Taking ownership of that blame was crucial. Once I could realize where I was wrong, in what I call the fourth column in the resentment list, I started getting some relief. I began to realize how I'd been a contributor to the ill feelings that I had. When inventorying a resentment, sometimes I'd determine that I wasn't the main culprit at all. But when I can admit MY wrongs (many times with the help of a sponsor), I can take ownership of my part of that resentment. And then I can realize that if I hadn't said or done something out of line (the wrong), there would be no resentment to deal with at all. But what about those resentments that we had no percentage of the blame? Where we had no contribution whatsoever? We can then treat that person who wronged us as perhaps spiritually sick. We asked God to help us show them the same tolerance, pity and patience that we would cheerfully grant a sick friend.

Now regarding fear. It used to rule my life before I found my higher power, who I choose to call God in A.A. After taking the time to list my fears I was able to come to the realization that I lacked faith. Ever so slightly things began to change once I asked God to remove my fears. Now, the more I'm able to hit my knees and say the Seventh Step Prayer morning and night, the more faith I have. And the fear problem has been solved.

Now about sex, the third and final list of the 4th Step. Not only can it be used to review our conduct over the years past, but it can be used to find our fault by asking the question-who did we hurt? Where had we been selfish, dishonest or inconsiderate? What should we have done instead? When we get this down on paper, we can see how our own conduct over the past contributed to the making of some toxic relationships or others that weren't lifelong. If we have harmed others, we make amends wherever possible except when to do so would cause still more harm. We treat sex as we would any other problem on this journey of recovery.

So, the 4th Step has allowed me to take ownership of my bad behavior and make some changes with a resulting better me, which has allowed this sober alcoholic to live a wonderful life.

# Tradition 4

"Each group should be autonomous in its own affairs, except in matters affecting other groups or AA as a whole."

It's comforting to know that we can go anywhere in the entire world and attend an AA meeting that looks very much like every other that we've experienced, It's remarkable that even though the 4th tradition allows us enormous freedom to conduct our gathering any way we like that in the final analysis, we have Spiritual Guidance and most gatherings resemble all others. Some of us include different readings, or prayers, or incantations, but we are in a way amorphous.

There had to be some cap on this license or the apostles and power drivers among us might have led us into all kinds of revelry in the name of modernization and improvement of our beloved program. It is humility that allows us to conform and leave well enough alone.Some of us are convinced, at times, that we have discovered a better way, and that if we just include an outside entity, like a church, or that church's higher power, or a community service, we might gain strength. It seems logical to some of us that teeming up with law enforcement, or temperance societies, might be

advantageous to both. The founders were tempted by this but found it a failure.

Modern innovations have changed some aspects of the AA meeting experience. Some members have opted for join groups online. This is different and not everybody is fond of this approach, but Tradition Four is not offended and it fits within the guidelines. As long as there are no "pop ups" inviting church attendance, soliciting funds for community do gooders, it is still AA. we cannot ignore or control progress and all of us must continuously monitor our performance lest we lose the precious, miraculous entity granted us by our Higher Power and protected by group conscience.



# **Treasurer and Office Report**

Good evening!

What new? Claudia covered the office for us on February 7th, 2025, thank you Claudia!

Glenda opened the office on Monday the 3<sup>rd</sup>, with the introduction of restored office hours. The office is open on Mondays again unless it is a federal holiday!

I added photos of the products we have in the office into our Venmo account earlier this month.

We received a notice from the State of California stating a new requirement we have as an employer with 4 or less employees. This office was required to sign up and offer our employees an opportunity to save money through the state's **CalSaver's** program. As an employee we signed up and registered, a s an employee I opted out of participating so, we are good there for now.

We successfully renewed our insurance, we originally paid \$1000, but our carrier found us a cheaper option so we are expecting a refund around \$500.

We received a notice from our credit card processing company that they are raising their fees effective March 27<sup>th</sup> 2025 from 2.6% plus 0.10 cents per transaction up to 3.5% plus .15 cents per transaction.

OK financial info:

For the period from Jan 21, 2025 thru Feb 20th, 2025 Central Office had an income of \$3,721.68 and expenses of \$5,527.95 for a *loss* of \$1,806.27 for this accounting period.

On February 19<sup>th</sup> we filed our exempt entity tax returns for Federal and State along with our Registry for Charitable Trusts and Fundraisers form through our landlord's firm. She only charged us \$300, which is a fantastic price!


# <u>Lighter Side of AA</u>
